

NEWSLETTER No. 3:

Clark Avenue West – Road Rehabilitation and Watermain Replacement

April 8, 2019

Commencing on April 23, 2019 (weather permitting) the City of Vaughan's Contractor will begin mobilizing to complete the replacement of the watermain on Clark Avenue West from Bathurst Street to Yonge Street. The construction of the watermain, water services and final restoration works is anticipated to be completed by November 2019.

PLANNED CONSTRUCTION WORK

The scope of work under this Contract includes the replacement of existing watermain, hydrants and water services and all associated work and restoration.

Before the construction begins, the underground utilities, including watermain, sewers, gas, hydro and telephone, will be marked to avoid potential issues when digging.

Road rehabilitation on Clark Avenue extending from Yonge Street to west of Dufferin is planned to follow in 2020 along with the construction of inboulevard cycling facilities. An updated newsletter will follow upon completion of the detailed design phase of this work.

CONSTRUCTION IMPACTS ON LOCAL RESIDENTS AND TRAFFIC

- Roads will remain open to vehicular and pedestrian traffic during construction. Temporary lanes restrictions will be required to allow construction activities to proceed in a safe and efficient manner.
- Disruption of waters services will be required as part of the project. To minimize impact during typical business hours the shutdown's for commercial businesses will be scheduled during evening and overnight hours where required. Additional notices will be circulated at least 48 hours in advance to all impacted residents and businesses.
- To minimize the overall impacts and duration of the project, components of the watermain installation may also be staged and completed during evening hours.
- Access to private and commercial driveways and entrances will be impacted at times during the watermain replacement and associated restoration works. Work at the location of commercial entrances will be staged so that continued access is maintained during business hours.


