# THE DRAFT VAUGHAN MILLS CENTRE SECONDARY PLAN (File 26.1)

Two opportunities to provide input into the finalization of the draft Vaughan Mills Centre Secondary Plan will be provided in the form of a Public Open House #3 and a Public Hearing Meeting before Committee of the Whole. The Public Open House will build upon the input received in the two previous Public Forums held in 2012. The dates, times and locations of these two events are set out below.

**PROPERTY:** The lands subject to the Secondary Plan are generally bounded on the north

by Rutherford Road; on the west by Weston Road; on the south by Bass Pro-Mills Drive; and on the east by Jane Street, including two parcels immediately fronting the east side of Jane Street between Rutherford Road

and River Rock Gate. (See reverse for map.)

PURPOSE: The Vaughan Official Plan 2010 (VOP 2010) requires the preparation of a

Secondary Plan (Official Plan Amendment) to permit the development of the subject lands in accordance with the policies of the Vaughan Official Plan 2010. The Plan builds upon the existing land use framework identified in Volume 1 of the Vaughan Official Plan 2010, and provides further detailed development policy framework for lands designated as "Employment Area" and "Greenway" west of Highway 400; and "High-Rise", "Mid-Rise", "Low-Rise Mixed Use", and "Public Open Space" designations for lands east of

Highway 400.

Comments provided at this Meeting will be considered prior to the Secondary Plan document being finalized and brought forward to Committee of the Whole for consideration. The Draft Secondary Plan will be subject to a further technical report to Committee of the Whole at a later date. #### **NOTE**

#### Official Plan (O. Reg. 543/06)

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Vaughan before the proposed Official Plan Amendment is adopted the person or public body is not entitled to appeal the decision of The City of Vaughan or The Regional Municipality of York, as the case may be, to the Ontario Municipal Board.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City of Vaughan before the proposed Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.

If you wish to be notified of the adoption of the proposed Official Plan Amendment, or of the refusal of a request to amend the official plan, you must make a written request to the City of Vaughan, City Clerk's Office, 2141 Major Mackenzie Drive, Vaughan, Ontario L6A 1T1.
