**DECLARATION OF QUALIFICATIONS

Do Solemnly Declare That:

1. I am or will be qualified pursuant to the Municipal Elections Act, 1996 and the Municipal Act, 2001, to be elected to and to hold the office of \_\_\_\_\_.
2. Without limiting the generality of paragraph 1, on voting day, November 13, 2006, I will be a Canadian citizen, at least eighteen years of age, a resident of the City of Vaughan or the owner or tenant of land in the City of Vaughan or the spouse or same sex partner of such owner or tenant.
3. I am not ineligible or disqualified under the Municipal Elections Act, 1996, the Municipal Act, 2001, the Municipal Conflict of Interest Act or any other Act to be elected to or hold the above-mentioned office.
4. Without limiting the generality of paragraph 3,
  - I am not an employee of the City of Vaughan, or if I am an employee of the City of Vaughan, I am on an unpaid leave of absence as provided for by section 30 of the Municipal Elections Act, 1996.
  - I am not a judge of any court.
  - I am not a member of the Assembly as provided in the Legislative Assembly Act or of the Senate or House of Commons of Canada or, if I am such a person, I will provide proof of my resignation in a form satisfactory to the Clerk of the City of Vaughan prior to 5:00 p.m. on Nomination Day, September 29, 2006. I understand that the Clerk of the City of Vaughan will reject my nomination for the above-mentioned office if I fail to provide proof of resignation by this deadline.
  - I am not a member of the Executive Council of Ontario or a federal Minister of the Crown.
  - I am not a Crown employee within the meaning of the Public Service Act, or if I am a Crown employee, I have followed and will continue to follow all the relevant provisions of Part III of such Act.
5. I am not prohibited from voting at the municipal election under subsection 17(3) of the Municipal Elections Act, 1996.
6. Without limiting the generality of paragraph 5,
  - I am not a person who is serving a sentence of imprisonment in a penal or correctional institution.
  - I am not a person who was convicted of a corrupt practice described in subsection 90(3) of the Municipal Elections Act, 1996, during an election that occurred less than four years prior to Monday, November 13, 2006.
7. I am not a candidate who was convicted of a corrupt practice under the Municipal Elections Act, 1996 or of an offence under the Criminal Code (Canada), in connection with an act or omission with respect to a municipal election if the voting day in that election is less than six years prior to Monday, November 13, 2006.
8. I am not disqualified from being elected to or holding office by reason of any violations of the election campaign financial requirements or violations for not filing the financial statement pursuant to the Municipal Elections Act, 1996.

AND I make this solemn Declaration conscientiously believing it to be true, and knowing that it is of the same force and effect as if made under oath and by virtue of the Canada Evidence Act.
