**Member's Resolution**

**Whereas**, the City of Vaughan has established the Civic Hero Award as a means of honouring citizens who have taken exemplary action in carrying out their responsibility as a citizen under the City of Vaughan Declaration of Citizens' Rights and Responsibilities; and

**Whereas**, the Civic Hero Award has been established such that each Ward Councillor has the authority to nominate one resident in their respective ward per year; and

**Whereas**, Hugh Cook exemplifies community volunteerism and leadership through his passion of preserving the history of Vaughan as a twenty-two year member of the Vaughan Historical Society. Throughout his tenure with the Society he has worked on transcribing the City of Vaughan cemeteries, and culminated with the publication in 2011 with the printing of his book called "Some of Vaughan's Pictorial Past". As a member of the executive of the Vaughan Historical Society, Mr. Cook maintains inventory and access to a number of printed materials on local history including "History of Vaughan", "A Few Old Barns", "History of Vaughan Township Churches", videos and historical maps.

**It is therefore recommended that** Hugh Cook be named the Ward 1 Civic Hero for 2012 and that the award be presented at a future Committee of the Whole, Committee of the Whole (Public Meeting) or Council meeting, at a date suitable to both staff and the recipient of the award.
